ALL that lot of land with the buildings and improvements thereon, situate on the North side of Kirkwood Lane in the City of Greenville, Greenville County, S. C., being shown as the greater portion of Lot No. 160 on plat of Isaqueena Park, made by Pickell & Pickell, June 3, 1947, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, at Pages 130 and 131, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Kirkwood Lane at joint front corner of Lots 160 and 161, and runs thence along the line of Lot 161, N. 14-59 E., 175 feet to an iron pin; thence N. 71-46 W., 60.9 feet to an iron pin; thence through Lot 160, S. 16-23 W., 116.1 feet to an iron pin; thence S. 19-39 W., 59.1 feet to an iron pin on the North side of Kirkwood Lane; thence along Kirkwood Lane, S. 72-31 E., 70 feet to the beginning corner.

Pogether with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attacked to or used in connection with the real estate herein described.

To Have and to Hold, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
