Office for Greenville County in Mortgage Book 848, at Page $505$ at the rate of $$156.61$ per month, bearing interest at the rate of $5\frac{1}{2}$ % per annum, payable monthly, and that so long as said payments are made promptly on the first day of each and every calendar month this loan shall not be considered delinquent, but should the said obligor (s), or his grantee, or assigns, fail to make said payments as agreed, then in that event, the holder of this mortgage may institute foreclosure proceedings without further delay according to the terms as set out in said note and mortgage.
