SEND GREETINGS:

VILLE, in the full and just sum of Nine Thousand, Nine Hundred and No/100--(\$ 9,900.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Sixty-Three and 79/100------(\$ 63.79 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "BEGINNING at an iron pin on the northeastern side of Glenmore Drive at the joint front corner of Lots Nos. 8 and 9, and running thence with said Drive, N. 65-36 W. 86.8 feet to an iron pin (subject to the turnaround as shown on said plat); thence with the same course 6.3 feet to a concrete marker on the line of Epps Property; thence with the line of Epps Property, N. 25-34 E. 176.7 feet to a concrete marker on the bank of Langston Creek, which marker is set 8 feet from the center of said Creek and using said center of said Langston Creek as the line, the traverse of which is S. 85-52 E. 92 feet to an iron pin on the northern bank of said Langston Creek at the rear corner of Lots Nos. 8 and 9; thence continuing with the line of said lots, S. 23-15 E. 208.6 feet to the beginning corner; being the same conveyed to us by Levis L.
