M. C. Office for Greenville County in Plat Book DDD, at Page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Welcome Road, joint front corner lots #2 and #3, running thence along the joint line of said lots, N. 39-02 E. 165.5 feet to an iron pin at the joint rear corner of lots #2 and #3; running thence N. 50-05 W. 63.9 feet to an iron pin at the joint rear corner lot s #1 and #2; running thence S. 41-10 W. 163.0 feet to an iron pin on the northern side of Welcome Road; thence along the northern side of Welcome Road, which line is curved, the chord of which is S. 49-05 E. 90.0 feet to an iron pin, point of beginning.
