WHEREAS, the Mortgagor is well and truly indebted unto The Peoples National Bank, Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Fifteen Thousand and No/100 ------ DOLLARS (\$15,000.00), with interest thereon from date at the rate of 5 1/2 per centum per annum, said principal and interest to be repaid:

Payable \$375.00 on principal May 27, 1964, and \$375.00 on principal quarterly thereafter until paid in full, with interest therefrom from date at the rate of 5 1/2% per annum, to be computed and paid quarterly, until paid in full; all interest not paid when due to bear interest at the same rate as principal.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, containing six acres, more or less, situate at the northwestern corner of the intersection of Congaree Road and Roper Mountain Road, and being more particularly described as follows:

"BEGINNING at an iron pin in the center of the intersection of Congaree Road and Roper Mountain Road, and running thence with the center of Roper Mountain Road N. 23 W. 417.12 feet to pin; thence continuing with the center of Roper Mountain Road N. 43-37 W. 411.9 feet, more or less, to pin; thence S. 19-32 W. 696.6 feet to pin in center of Congaree Road; thence with the center of Congaree Road as a line S. 85-56 E. 660.5 feet to the point of beginning."

Said premises being the same conveyed to the mortgagor by three separate deeds, recorded in Volume 00 at Page 612, Volume 161 at Page 490, and Volume 493 at Page 342 respectively.
