All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Eastern side of Catlin Circle in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 37 as shown on a plat of Section One, Hyde Park Subdivision, prepared by R.B. Bruce, dated June, 1963, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at page 141, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Catlin Circle at the joint front corner of Lots Nos. 37 and 38, and running thence with the line of Lot No. 38 N. 65-49 E. 115.9 feet to an iron pin; thence N. 3-45 W. 50 feet to an iron pin at the joint rear corner of Lots Nos. 36 and 37; thence with the line of Lot No. 36 S. 76-58 W. 143.8 feet to an iron pin on the Eastern side of Catlin Circle; thence with the Eastern side of Catlin Circle S. 30-00 E. 75 feet to the point of beginning.
