NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Hialeah Road in the City of Greenville, being known as Lot 324 on plat of Section B, of Gower Estates, made by R. K. Campbell, Surveyor, Dec. 1961, and recorded in Plat Book XX at Page 36-37.

BEGINNING at an iron pin on the west side of Hialeah Road at the joint front corner of Lot Nos. 323 and 324 and running thence along the line of Lot No. 323, N. 87-25 W. 176 feet to an iron pin; thence N. 2-35 E. 135 feet to an iron pin; thence with line of Lot No. 325, S. 76-13 E. 194.1 feet to an iron pin on the West side of Hialeah Road; thence with the curve of Hialeah Road (the chord being S. 10-53 W. 95 feet) to beginning corner.
