All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being at the Southwestern corner of the intersection of Sharon Drive and Melody Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 69 as shown on a plat prepared by C.C. Jones, Surveyor, dated December, 1962, entitled "Extension of Sharon Park", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CCC at page 71, and having according to said plat the following metes and bounds:
