TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Jackie A. Peden

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, Fairview Township, containing 7.21 acres, more or less, and having the following courses and distances, to-wit: Beginning at a Nail in center of McKittrick Road and running thence along the W. M. Hepkins property line S.81-49 E.837.9 feet to a Stone on the Jim Peden property line, thence with said property line last mentioned S.6-37 W.381.2 feet to an Iron Pin, thence along the Jim Peden property line N.82-00 W.510 feet to an Iron Pin, thence along the Ronie Peden property line N.49-45 W.183.7 feet to an Iron Pin, thence with the Ronie Peden property line N.83-11 W.290.3 feet to a Nail in center of said road, thence with the center of said road N.28-19 E.311.4 feet to the beginning point.
