(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of NINETY-FIVE HUNDRED and no/100--- DOLLARS (\$9,500.00), with interest thereon from date at the rate as specified in said note, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of the Duncan Road, in Berea Community, Paris Mountain Township, and being known and designated as Lot No. Twelve (12) of the James H. & Inez H. Sutton property as shown on plat prepared by Pickell & Pickell, Engineers, dated August 23, 1955 and which plat has been recorded in the R. M. C. Office for said County in Plat Book JJ, page 63, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the Northwest side of Duncan Road, joint front corner of lots nos. 11 & 12 as shown on said plat, and running thence with the joint property line of said two lots N.42-11 W.149.4 feet to an Iron Pin at the joint rear corner of lots nos. 5 & 6 as shown on said plat, thence with the joint property line of lots nos. 6 & 12 N.35-12 E.76.8 feet to an Iron Pin at joint rear corner of lots nos. 12 & 13 as shown on said plat, thence with the joint property line of said last two mentioned lots S.42-11 E.106.2 feet to an Iron Pin on Northwest side of said road, thence with the Northwest side of said road S.47-49 W.75 feet to the beginning point. This being the same property which was conveyed to Gaston B. Cox by James D. Cordell by deed recorded in said office in Deed Book 670, page 289. And being the same property which was conveyed to mortgagor herein by Gaston B. Cox by deed which will be recorded forthwith in the said office.
