NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, Montez

B. Sloan and her heirs and assigns:

All those certain parcels or lots of land lying on the south side of U.S. Super mighway No. 29 about two miles west from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being all of Lot No. 2 and the eastern one-half of Lot No. 3 of the property of G.V. Sloan and V.S. Sloan according to survey and plat by Robert Jordan, Surveyor, dated July, 1957, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the right-of-way of said U.S. Highway, corner with the Wingo property and runs thence with said right-of-way S. 68-00 W. 50 feet to an iron pin, joint corner of Lots Nos. 1 and 2 on said plat; thence with the common line of Lots Nos. 1 and 2 and line which divides Lot No. 3, S. 22-27 E. 227 feet to a point on rear line of Lot No. 3; thence N. 66-48 E. 50 feet to an iron pin on Wingo line or corner; thence N. 22-27 W. 225.9 feet to the beginning corner.
