WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN COMPANY

, a corporation organized and existing under the laws of the state of North Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand Six Hundred Fifty and No/100------Dollars (\$10,650.00), with interest from date at the rate per centum (5 1/4 of five and one-fourth %) per annum until paid, said principal and interest being payable at the office of Cameron-Brown Company, 900 Wade Avenue in Raleigh, North Carolina , or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty-Eight and 89/100-------- Dollars (\$ 58.89 , 1964 , and on the first day of each month therecommencing on the first day of December after until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November

Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the North side of Skyland Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 44 on plat of Sans Souci Heights, recorded in the RMC Office for Greenville County, S. C. in Plat Book Y, Page 25; said lot fronting 83 feet along the North side of Skyland Avenue, running back to a depth of 131.5 feet on the East side, to a depth of 125 feet on the West side, and being 66.4 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
