TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Hattie V. Henderson and

Joe R. Henderson, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Thirty-five hundred -----
DOLLARS (\$ 3500.00), with interest thereon from date at the rate of Six & one-half (6 1/2) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on both sides of Gap Creek Road and the east side of Cannon Road near Washington Baptist Church, bounded by lands now or formerly owned by Washington Baptist Church, Furman Bomar Estate, Dan Ray, W.W. Atkins and Furman Dill Estate and also Grover and Betty Mason, containing 19 acres, more or less, and being the property conveyed to Hattie V. Henderson by deed of Amanda E. Roe recorded in Deed Book 180, page 156, R.M.C. Office for Greenville County, LESS THEREFROM, lots owned by Grover and Betty Mason, J. Paul Henderson and D.M. Leonard.

This is the same property upon which is located the homeplace of Hattie V. Henderson and the home of Joe R. Henderson located on the north side of the Gap Creek Road, and a tract of vacant land on the south side of the said road, the same being further identified on the County Block Book Map as 631.5-1-20 and 22.
