KNOW ALL MEN BY THESE PRESENTS, That the said Carrie Dell Edwards Humphries , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Citizens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, on the south side of Palmer Street in the Town of Greer, being shewn and designated as Lot No. 2 of a plat of the property of O. P. Smith, prepared by W. A. Christopher, March 17th, 192h, and being all of the same lot of land conveyed to Benn Harold Ross by Irene Brooks by Deed recorded in R. M. C. Office for Greenville County in Book 457, page 130 and having the following courses and distances:

BEGINNING on an iron pin on the South side of Palmer Street, joint corner of Lots #2 and #3 and runs thence with the dividing line of Lots #2 and #3 S. 21-00 W. 200 feet to iron pin, joint corner of Lots #2 and #3 on the line of a one acre lot; thence with the line of the one acre lot N. 69-00 W. 60 feet to iron pin; joint corner of Lots #1 and #2; themce with the dividing line of Lots #1 and #2 N. 21-00 E. 200 feet to iron pin on the south side of Palmer Street; thence with the south side of Palmer Street S. 69-00 E. 60 feet to the beginning corner.
