ALL that piece, parcel or lot of land with all improvements  
thereon situate, lying and being in Gantt Township, Greenville County,  
S. C. known and designated as a portion of Lot No. 24 of Conestee as  
shown by plat thereof made by R. E. Dalton, Eng. dated December 1943  
and recorded in the RMC Office for Greenville County in Plat Book K  
at page 276 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on Main Street, joint corner of Lots 23  
and 24 and running thence with Main Street, North 42-48 East 60 feet;  
thence North 47-12 West 175 feet; thence South 42-48 West 60 feet to
