"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Situate, lying and being on the southern side of Patti Drive, near the City of Greenville, being known and designated as Lot 13 as shown on plat of Staunton Heights, recorded in Plat Book RR at Page 167 and having the following metes and bounds, to wit:
