securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina: in the City of **Greenville, S. C.** on the western side of **LeGrand**
Boulevard and being known and designated as **Lot No. 127 of Sherwood Forest** as shown
on plat thereof recorded in the **R. M. C. Office for Greenville County in Plat Book**
"BB", at Pages **30 and 31** and having, according to said plat, the following metes and

1-30 E. 70 feet to an iron pin; thence **S. 88-30 W. 150 feet** to an iron pin; thence

assigns forever.
