NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, containing approximately 2 acres more or less as shown by a plat made by C. O. Riddle on July 7, 1958 entitled "Property of Tom Davis, Greenville County, South Carolina and having according to said plat the following metes and bounds, to-wit:

BEGINNING at pin on the eastern side of S. C. Highway 417 (Georgia Road) at corner of property owned by Tom Davis and running thence with the eastern edge of said Highway 600 feet more or less to a pin on the line of the property of Nannie C.
