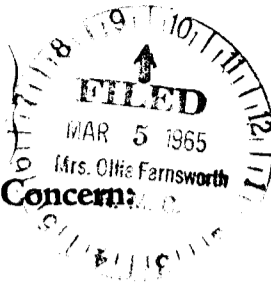

Bank of Piedmont, ALL that certain piece, parcel or lot of land, with all all improvements thereon, or hereafter constructed thereon, situate, lying, and being in the State of South Carolina, County of Greenville, Grove Township, lying and situated in Grove Station School District, State and County aforesaid, and containing one-half (1/2) acre, more or less, having the following metes and bounds to wit:
