All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Bates Township**, at **Travelers Rest, South Carolina**, known as **Lot #8** and a portion of **Lot #9** as shown on plat of **R. E. Benson**, recorded in the **RMC Office for Greenville County in Plat Book H at Page 218** and having, according to said plat, the following metes and bounds to-wit:

Beginning at an iron pin on the southern side of **McElhaney Road**, at the joint front corner of **Lots #7 and #8**, and running thence **S 33-0 E 230** feet to an iron pin; thence **N 33-3/8 E 108.9** feet to an iron pin; thence **N 33 W 200.7** feet to an iron pin on **McElhaney Road**; thence with said road **S 51 W 100** feet to the point of beginning.
