WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

--EIGHTEEN THOUSAND FIVE HUNDRED AND NO/100--

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate on the northern side of Beaufort Street, near the City of Greenville, being shown as lot # 115 on plat of HERITAGE HILLS, recorded in Plat Book YY at Page 187, and described as follows:

BEGINNING at an iron pin on the northern side of Beaufort Street, at corner of lot 114, and running thence with the northern side of said street, the chords of which are N. 89-15 W. 65 feet and S. 76-29 W. 25 feet to iron pin at corner of lot 116; thence with line of said lot, N. 6-25 W. 178.9 feet to iron pin in line of lot 111; thence with the line of said lot, N. 76-11 E. 48.5 feet to iron pin at corner of lot 112; thence with line of said lot S. 76-30 E. 95 feet to iron pin at corner of lot 114; thence with line of said lot, S. 10-22 W. 164.6 feet to the beginning corner.
