WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile northward from Chick Springs on the west side of the St. Mark Road, having the following courses and distances, to-wit:

BEGINNING on an iron pin on the west margin of the said St. Mark Road, joint corner of a lot now or formerly owned by Ernest and Pearl Chappell, and runs thence with the line of said Chappell lot, S. 67-37 W. 312 feet to an iron pin; thence S. 10-36 E. 120.1 feet to an iron pin; thence N. 69-40 E. 181.4 feet to an iron pin in driveway; thence with the said driveway, N. 60-43 E. 154 feet to an iron pin in center of the driveway and on the west margin of the said St. Mark Road; thence with the west margin of the said road, N. 21-05 W. 106.2 feet to the beginning corner.
