WHEREAS, the Mortgagor is well and truly indebted unto
CAMERON-BROWN COMPANY

, a corporation
organized and existing under the laws of North Carolina , hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Twelve Thousand Five Hundred
Fifty and No/100----- Dollars (\$ 12,550.00), with interest from date at the rate
of five and one-fourth per centum (5 1/4 %) per annum until paid, said prin-
cipal and interest being payable at the office of Cameron-Brown Company
in Raleigh, N. C.

or at such other place as the holder of the note may designate in writing, in monthly installments of
Sixty Nine and 40/100----- Dollars (\$ 69.40),
commencing on the first day of July , 19 65 , and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of June , 19 95.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, his
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina: near Greenville, S. C. on the southern side of Piccadilly

Drive and being known and designated as Lot No. 34, Block B, Mayfair Estates,
as shown on plat thereof recorded in the R. M. C. Office for Greenville County
in Plat Book "S", at Pages 72 and 73 and having, according to said plat, the
following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Piccadilly Drive at the
joint front corner of Lots Nos. 34 and 33 and running thence along said Drive, N.
83-17 E. 119 feet to an iron pin; thence S. 25-23 W. 227.4 feet to an iron pin;
thence N. 6-13 W. 192.8 feet to the point of beginning.
