SEND GREETING:

WHEREAS, we the said Robert N. Polson, Jr., and Miriam S. Polson in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S.
