All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed the situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Lot 29 of a subdivision known as McSwain Gardens as shown on plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book GG at Page 75 and having, according to said plat, the following metes and bounds, to-wit:
