All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the western side of Wintergreen Lane, being known and designated as Lot No. 56 on a plat of a portion of Section II Brookwood Forest by Webb Surveying and Mapping Company dated November, 1964 and recorded in the R. M. C. Office for Greenville County in Plat Book BBB, Page 80, and being more particularly described as follows:

BEGINNING at an iron pin on the western side of Wintergreen Lane, joint front corner of Lots 56 and 57, and running thence with the joint line of said lots, N. 61-33 W. 150.6 feet to an iron pin on Rutherford Road, joint rear corner of said lots; thence along said road, S. 25-27 W. 99.6 feet to an iron pin, joint rear corner of Lots 55 and 56; thence with the joint line of said lots, S. 61-22 E. 149.2 feet to an iron pin on Wintergreen Lane; thence with said lane, N. 26-21 E. 100 feet to an iron pin, point of beginning; being a portion of the property conveyed to the mortgagor corporation by M. A. Ashmore, et al. on July 25, 1962 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 704, Page 533.
