Nine Hundred Thirty-Five and No/100 ----- DOLLARS (\$ 935.00), with interest thereon from date at the rate of repaid:

Payable one year from date, with interest from date at the rate of seven (7) per cent per annum, to be computed and paid semi-annually in advance.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, about two miles northwest of Cleveland, situate on the northern side of Geer Highway, and being comprised of two separate parcels of land, which are described by metes and bounds in the deed recorded in Volume 210 at Page 101, reference be said deed being made for a more particular description."

ALSO

"All that other parcel or tract of land situate on the northern side of Geer Highway, adjoining the above described tract, being bounded on the west by land now or formerly owned by Dalton, on the north by Hart Valley Ranch property, on the east by Bunyan Jones and on the south by Geer Highway, containing 10 acres, more or less."
