"All that dertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Rocky Slope Road, near the City of Greenville, containing one-half acre according to a survey made by C. O. Riddle, on August 6, 1952, and is described as follows:

BEGINNING at a stake on the Southwestern side of Rocky Slope Road, 289 feet Southeast from Woodruff Road, at corner of other property of Mae Nesbitt Henderson, and running thence with the line of said property, S. 64-20 W. 146.5 feet to a stake; thence continuing with the line of the grantor's property, S. 37-00 E. 146.5 feet to a stake at corner of Lot No. 8; thence with the line of said lot, N. 64-20 E. 146.5 feet to a stake on Rocky Slope Road; thence with the Southwest side of said lot, N. 37-00 W. 146.5 feet to the beginning corner.

ALSO: An adjoining tract BEGINNING at an iron pin on the Southwest side of Rocky Slope Road, 8 feet Northwest from the most northerly corner of tract above described and running thence S. 67-39 W. 262.5 feet to an iron pin; thence S. 24-36 E. 167 feet to an iron pin; thence N. 64-20 E. 150.5 feet to an iron pin in line of the above tract; thence with the said tract, N. 37 W. 146.5 feet; thence N. 64-20 E. 146.5 feet; thence N. 36-48 W. 8 feet to the Beginning.
