"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed themon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, containing 2.33 acres, more or less, according to a plat and survey made by Carolina Engineering and Sunveying Company, R. B. Bruce, Surveyor, November 15, 1960, and having according to said plat, the following courses and distances, to-wit:
Beginning at an iron pin in the western edge of a dirt road on line of land formeraly belonging to L. R. Peden, and running thence S. 70-30 W. 3591 feet to a point in the center of the Fairview-Simpsonville Road, corner with lands formerly belonging to L. R.
