(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Link Street and having, according to a plat of the property of Robert A. Ambrose recorded in Plat Book LL at page 161, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Link Street 67.2 feet north from Ottaray Street, and running thence S. 89-51 W. 147.8 feet to pin; thence N. 3-34 E. 110 feet to pin; thence S. 86-30 E. 102.7 feet to pin on Link Street; thence with the western side of Link Street, S. 20-16 E. 110 feet to the point of beginning.
