BEGINNING at a point in center of road at corner of W. J. Cash, and running thence N. 37-30 W. .84 chains to a stake; thence N. 31-30 E. 6.22 chains to a stake; thence S. 38-00 E. 3.06 chains to a point in center of road; thence with center of said road, S. 52-30 W. 5.82 chains to the beginning corner.
