WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Three Thousand Twenty-five and no/100------DOLLARS (\$ 3,025.00). with interest thereon from date at the rate of 7 per centum per annum, said principal and interest to be repaid: in 35 monthly installments of \$84.03 and a final installment of \$83.95 to be applied to the principal beginning October 4, 1968 with interest thereon at the rate of 7% payable quarterly in advance.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, near the City of Greenville, on the Eastern side of North Parker Road, being shown on Plat of property of James L. Laur prepared by J. C. Hill, dated August 27, 1956, revised May 7, 1957, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the Eastern side of North Parker Road, the cornoer of property now or formerly owned by James L.
