

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city of Greenville, being known and designated as Lot No. 49 according to plat of Pine Hill Village prepared by R K. Campbell, RLS. July 9, 1962 as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ at page 169 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the easterly side of Cashmere Drive at joint front corner of Lots 48 and 49 and running thence along the joint line of the said lots N. 74-14 E. 125 feet to an iron pin on the rear line of Lot 200; thence S. 15-46 E. 72 feet to an iron pin at the joint rear corner of Lots 48 & 49; thence along the joint line of the said lots S 74-14 W. 125 feet to an iron pin on the easterly side of Cashmere Drive; thence along said Cashmere Drive N. 15-46 W. 72 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
