"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as "Plat of lot surveyed for T. A. Roe" in Plat Book I at page 68 in the RMC Office for Greenville County, containing one acre, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Buncombe Road at the corner of land now or formerly owned by W. F. Thackston and R. K. Taylor, and running thence with the western side of Buncombe Road, S. 4-20 E. 118.4 feet to an iron pin; thence N. 88-20 W. 265 feet to an iron pin; thence N. 3-14 W. 152 feet to a pin in line of Thackston property; thence S. 81-00 E. 277 feet to the point of beginning.
