"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Twonship, containing approximately 2 scres more or less as shown by a plat made by 0.0. Riddle on July 7, 1958 entitled "property of Tom Davis, Greenville County, South Carolina and having according to said plat the following metes and bounds, to -wit:

BEGINNING at oin on the eastern side of S. C. Highway 417 (Georgia Road) at corner of property owned by Tom Davis and running thence with the eastern edge of said Highway 600 feet more or less to a pin on the line of the property of Nannie C. The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
