"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeastern side of Ponderosa Road, in the City of Greenville, being shown and designated as Lot No. 17 on a Plat of GOWER ESTATES, Section C-1, dated July 27, 1963, made by R. K. Campbell and Webb Surveying & Mapping Company, and recorded in the RMC Office for Greenville County, S. C., in Plat Book YY, page 112, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeastern side of Ponderosa Road at the joint front corners of Lots Nos. 16 and 17, and running thence along the common line of said Lots, S. 51-34 E., 238 feet to an iron pin; thence N. 24-52 E., 184.5 feet to an iron pin; thence along the common line of Lots Nos. 17 and 18, N. 61-28 W. 200 feet to an iron pin on Ponderosa Road; thence along the Southeastern side of Ponderosa Road, S. 32-34 W., 75 feet to an iron pin; thence continuing along said side of Ponderosa Road, S. 40-50 W., 70 feet to an iron pin, the beginning corner.
