with interest thereon from ~~date~~ <sup>December 31, 1971</sup> at the rate of ~~four~~ <sup>four</sup> per centum per annum, said principal and interest to be repaid: in annual installments of \$4096.00 each commencing on December 31, 1969, and a like payment on the 31st day of December each year thereafter until paid in full

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 5, 9, 11, 21, 24, 26, 30, 36, 37, and 40 of Rosamond Estates as shown on plat recorded in Plat Book JJJ at page 29 in the RMC Office for Greenville County, reference to said plat being made for a more complete description.

This is a purchase money mortgage given to secure the balance of the purchase price of the within described property.
