TO ALL WHOM THESE PRESENTS MAY CONCERN: McCall-Threatt Enterprises, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Eugenia R. Brashier

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of - - - - -

TWENTY TWO THOUSAND EIGHT HUNDRED EIGHTY AND NO/100 DOLLARS (\$22,880.00),
December 31, 1971

with interest thereon from ~~date~~ at the rate of four per centum per annum, said principal and interest to be repaid: in annual installments of \$4576.00 each, commencing on the 31st day of December, 1969, and a like payment on the 31st day of December each year thereafter until paid in full

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 2, 14, 18, 19, 25, 27, 34, 47, 53, and 4 of Rosamond Estates as shown on plat recorded in Plat Book JJJ at page 29 in the RMC Office for Greenville County, reference to said plat being made for a more complete description.

This is a purchase money mortgage given to secure the balance due on the purchase price of the within described property.

The Mortgagee herein agrees to release lots in accordance with the terms of an agreement of even date to be executed herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
