WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Fifteen Thousand Two Hundred and No/100ths----**

DOLLARS (\$ 15,200.00), with interest thereon from date at the rate of **Seven** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, being known and designated as **Lot 72 of Longforest Acres as shown on plat recorded in the R.M.C. Office for Greenville County in Plat Book JJJ, page 79 and having the following metes and bounds, to-wit:**

BEGINNING on the southern side of Pueblo Drive at the corner of Lot 71 and running thence S 34-49 E 160 feet to an iron pin; thence N 57-14 E 16.6 feet to an iron pin; thence N 21-26 E 160 feet to the southern side of Pueblo Drive; thence with it N 68-34 W 61.5 feet to an iron pin; thence with the curve of said Drive, the chord of which is S 83-19 W, 44 feet; thence with said Drive S 55-11 W 76.6 feet to the point of beginning and being same conveyed to us by deed of Leon Moody to be recorded of even date herewith.
