C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing by estamation to be five (5) acres more or less. Being all that land that lies East of the branch of the tract of land that was deeded to Nicie Center, by deed recorded in Deed Pook 125 page 188, R. M. C. Office for Greenville County, Bounded by lands of L. W. Stringer and Mrs. L. E. Stringer and the above mentioned branch.

This is the same property that was deeded to H. E. Stringer by deed dated June 7, 1956, and recorded in Deed Book 458 page 465 R. M. C. Office for Greenville County.

ALSO: All that piece, parcel or lot of land in Highland Township, Greenville County State of South Carolina, lying on the South side of Fortenberry's Beaverdam Creek being bounded on the North by a branch and the said Fortenberry's Beaverdam Creek, on the East by lands of Omie Morrow, on the South by lands of Johnnie Suddith and J. T. Moon, and on the West by J. T. Moon, center of the above mentioned branch, and being a part of the same land that was conveyed to Elbert P. Moon line and joint corner of Johnnie Suddith, and runs thence with the Johnnie Suddith line N. 41-12 E. 1112 feet to a pine stump, joint corner of Johnnie Suddith, Omie Morrow and the tract being conveyed, thence with the Omie Morrow line N. 12-39 W. 1450 feet to a point in the said Fortenberry's Beaverdam Creek and on the Morrow line; thence up the said creek S. 64-00 W. 525 feet, more or less, to a persimon (down) on the northern bank of the creek, old corner; thence S. 1-30 W. 50 feet crossing the creek to a bend in the above mentioned branch; thence continueing up the said branch and with its meanderings as follows: S. 70-30 W. 211.7 feet to bend; S. 60-05 W. 278.7 feet to a bend; S. 53-58 W. 333.6 feet to a bend; thence S. 14-13 E. 91.7 feet to a bend; S. 31-10 W. 181.7 feet to a bend; S. 10-00 W. 253.4 feet to a bend; S. 10-58 W. 120 feet to a bend; S. 91 feet to a bend; S. 7-35 W. 63 feet to a Plack Cum 3X 0. M., on the Southeastern side of the said branch, joint corner of the center land: thence with the center line S. 73-00 E. 681 feet to a stake, joint corner with the center land; thence S. 32-00 W. 727 feet to a stake on the Moon line and Center's corner: thence with the Moon line S. 59-40 E. 425 feet to the beginning corner, and containing Fifty Two and Twenty Five One-hundredths (52.25) Acres, more or less.
