MORTGAGE OF REAL ESTATE

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being the northeasterly 55 feet of Lot No. 41 and the southwesterly 55 feet of Lot No. 42, as shown on plat of Avon Park, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", at Page 71, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the westerly side of Thames Drive, which iron pin is located 25 feet in a southeasterly direction from joint front corner of Lots Nos. 42 and 43, and running thence along said Drive S. 5-42 W. 110 feet; thence on a new line through Lot No. 41 S. 84-18 W. 175 feet to an iron pin; running thence N. 5-42 E. 110 feet to an iron pin in rear line of Lot No. 42; thence on a new line through Lot No. 42 N. 84-18 E. 175 feet to the point of BEGINNING.
