

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) is well and truly indebted unto Peoples National Bank

maturity with interest thereon from Tate at the rate of 7%

per centum per annum, to be paid: in advance

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, and containing 51 3/4 acres, more or less, and being the same tract of land conveyed to John Chapman by S.B. Huff, by deed dated March 24, 1923, recorded in Deed Book 97, Page 363. It is known as a portion of the old W. M. Yeargin Homeplace and begins at a rock and runs thence S. $5\frac{1}{2}$ W. 41.00 to a rock; thence N. 32 1/3 W. 10.37 to sweet gum; thence N. 66 W. 10.00 to a rock; thence N. 22 E. 14.30 feet to a rock; thence N. $12\frac{1}{2}$ E. 5.67 to rock; thence N. 27 W. 10.32 to a stake; thence N. 14 E. 10.20 to a rock; thence S. 57 E. 17.14 to the beginning corner, all of which is in accord with a plat made by J. D. Pearson dated September 1, 1887.

Being the same property conveyed to the mortgagor herein by deed of John Chapman recorded in the R.M.C. Office for Greenville County in Deed Volume 407 at Page 441.

This instrument is given as junior to a mortgage given the Farmers Bank of Simpsonville and recorded in Mortgage Book 1031 at page 657 in the Greenville County R. M. C. Office.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
