RELEASE FROM LIEN OF MORTGAGE

BEGINNING at an iron pin on the eastern side of Courtland Drive, joint front corner of Lots 10 and 11, and running thence S. 84-30 E., 653.2 feet to an iron pin; thence N. 5-41 E., 200 feet to an iron pin; thence N. 84-30 W., 403.8 feet to an iron pin; thence S. 5-30 W., 100 feet to an iron pin; thence N. 84-30 W., 250 feet to a point on the eastern side of Courtland Drive; and, thence S. 5-30 W., 100 feet to an iron pin, the point of beginning.
