SEND GREETING:

Whereas, I, the said Agnes Lee Campbell  
in and by my certain installment promissory note in writing, of even date with these  
Presents, am well and truly indebted to North Carolina National Bank, Tryon  
Office, a banking corporation of Charlotte, Mecklenburg County, N. C.,  
in the full and just sum of Seven Thousand Four Hundred Seventy Eight and  
10/100 (\$7,478.10) Dollars for money loaned  
, to be paid in installments of \$106.83 per month on the  
1st day of each succeeding month, beginning on March 1, 1969, and con-  
tinuing until said indebtedness has been paid in full. Each payment  
shall be credited first on the payment of interest then due and the  
balance on principal,

, with interest thereon from date on unpaid principal  
at the rate of SIX per centum per annum, to be computed and paid monthly as a part of the
