C. S. Willingham ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand Three Hundred and No/100 ----- DOLLARS (\$ 12,300.00 -----), with interest thereon from date at the rate of Seven ----- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being on the southern side of Ranier Street near the City of Greenville, and known and designated as Lot No. 35 of a subdivision known as Section C, Green Forest, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book KK at Page 87, and according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of Lots Nos. 34 and 35 on the southern side of Ranier Street and running thence with the joint line of said Lots S. 18-23 E. 175 feet, running thence N. 86-26 E. 100 feet to an iron pin at the joint rear corner of Lots 35 and 36, running thence with the joint line of said Lots N. 17-30 W. 198.8 feet to an iron pin on the southern side of Ranier Street, running thence with the southern side of said Street S. 71-37 W. 100 feet to an iron pin, point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
