All that certain piece, parcel, or took land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 10 acres, more or less, and being shown and designated as Property of J. J. McCarter on plat of property entitled "Survey for Charles B. Thomas", prepared by Carolina Engineering & Surveying Co., 25 April 1968, and revised 24 February 1969, said tract lying on the southerly side of an unnamed road, and having, according to the revised plat, the following metes and bounds, to wit:
