WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, on the north side of the Old Greenville-Spartanburg Road, approximately three (3) miles southward from the City of Greer, and being shown as the property of H. Gerald Bradley, according to a survey and plat by John A. Simmons, Registered Surveyor, dated February 29, 1968, recorded in Plat Book SSS, Page 71, R. M. C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a point in the center of the Old Greenville-Spartanburg Road, southwestern corner of the lot herein described and being the corner of W. M. Dillard property, iron pin on north bank at 23 feet, and running thence along said Road, S. 88-19 E. 240.6 feet, N. 87-00 E. 100 feet and N. 81-00 E. 100 feet to a point on said Road, iron pin on north bank at 4 feet; thence N. 6-00 W. 420 feet to an iron pin; thence S. 84-00 W. 438.3 feet to an iron pin; thence S. 6-00 E. 388.2 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
