All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Wilson Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 86 as shown on a plat of property of Eliza T. Looper, prepared by R. E. Dalton, dated December 1924, and having according to a more recent plat prepared by Campbell & Clarkson, dated February 26, 1969, entitled "Property of Dempsey Construction Co., Inc.", recorded in the R.M.C.
