"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Woodruff Road (S. C. Highway 146), known and designated as Lots Nos. 1 and 2 of the property of Bessie B. Smith and Lawtice B. Mitchell, plat of which is recorded in the R. M. C. Office for Greenville County in Deed Book XX at Page 169, having the courses and distances shown on said plat.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
