"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Balentine Drive in the City of Greenville, being shown as Lot 10 and a part of Lot 9 of Greenbriar Subdivision on plat recorded in Plat Book E at page 87, and being more particularly described as follows:

Beginning at an iron pin on the northeastern side of Balentine Drive at the joint front corner of Lots 10 and 11 and running thence with line of Lot 11, N 56-50 E 150.5 feet to an iron pin; thence N 40-52 W 117.3 feet to an iron pin in rear line of Lot 9; thence through Lot 9, S 56-57 W 131.1 feet to an iron pin on the northeastern side of Balentine Drive; thence with the northeastern side of Balentine Drive, S 33-10 E 116.5 feet to the beginning corner.
